SECTION 4 – FIRST-AID MEASURES

Inhalation

Remove source of exposure or move person to fresh air and keep comfortable for breathing. If breathing is difficult, trained personnel should administer emergency oxygen if advised to do so by the POISON CENTER/doctor. Eve Contact

Skin Contact

Take off all contaminated clothing and shoes immediately. Wash affected areas with plenty of flowing water/shower for a minimum duration of 30 minutes or until medical aid is available. Immediately call a POISON CENTER or a doctor.

Wash contaminated clothing before reuse or discard.

Ingestion

Rinse mouth. Do NOT induce vomiting unless under the advice of doctor or POISON CONTROL CENTER. Immediately call a POISON CENTER or doctor. If swallowed, concentrate may be corrosive to gastrointestinal system. Dilute stomach by giving water or milk. If vomiting occurs naturally, lie on your side, in the recovery position. NOTE: Never give anything by mouth to an unconscious or convulsing person. Keep person warm and quiet.

Emergency Procedure

General

Wash hands after use.

Eye Protection

Wear eye protection with side shields or goggles. Wear indirect-vent, impact and splash resistant goggles when working with liquids. If additional protection is needed for entire face, use in combination with a face shield.

Skin Protection

Use of gloves approved to relevant standards made from the following materials may provide suitable chemical protection: PVC, neoprene or nitrile rubber gloves. Suitability and durability of a glove is dependent on usage, e.g. frequency and duration of contact, chemical resistance of glove material, glove thickness, dexterity. Always seek advice from glove suppliers. Contaminated gloves should be replaced. Use of an apron and over- boots of chemically impervious materials such as neoprene or nitrile rubber is recommended to avoid skin sensitization. The type of protective equipment must be selected according to the concentration and amount of the dangerous substance at the specific workplace. Launder soiled clothes or properly disposed of contaminated material, which cannot be decontaminated.

Respiratory Protection


